RESOLUTION NO. 18-16

A RESOLUTION TO ALLOW FOR CENTRAL GEORGIA EMC ("CGEMC") TO OWN AND MAINTAIN CITY-STREET LIGHTS CONNECTED TO CGEMC'S SYSTEM; TO ALLOW FOR A RATE INCREASE; TO PROVIDE FOR AN EFFECTIVE DATE; AND TO PROVIDE FOR OTHER LAWFUL PURPOSES.

WHEREAS, the duly elected governing authority of the City of Hampton, Georgia is the Mayor and Council thereof (hereinafter "City"); and

WHEREAS, the City utilizes CGEMC energy for City-owned street lights; and

WHEREAS, currently, the City pays CGEMC for hosting the lights but is responsible for the lights' maintenance; and

WHEREAS, CGEMC proposes to transition to an arrangement where CGEMC would own and maintain the lights for a rate increase which includes replacing the lights to standard LED fixtures; and


WHEREAS, the attached rate increase, incorporated by reference, shall reflect the new arrangement to allow for CGEMC to own, service and maintain the City street lights; and

WHEREAS, it is in the City's best interest to enter into such arrangement for reduced confusion and enhanced customer service.

BE IT AND IT IS HEREBY RESOLVED by the Mayor and Council of the City of Hampton, Georgia, upon adoption of this Resolution, that the City agrees to have CGEMC upgrade, own, service, and maintain City street lights in exchange for a rate increase as reflected in the attached.





The lighting information we discussed yesterday is summarized in the table below.



The existing rates are for a light owned by the City of Hampton but connected to the Central Georgia EMC (CGEMC) system for energy. Under this arrangement, the City is responsible for maintaining the light. This arrangement was common in years past, but these three accounts with the City are the only lights we have on our system that are administered in this manner.

We are proposing to transition these lights to a standard arrangement where a light that is connected to the CGEMC system is owned and maintained by CGEMC. We made this transition with the City of Jackson last year, and it has greatly reduced operational confusion and enhanced customer service. In addition, we would change all of these lights to our standard LED fixtures upon this transition if approved.
