**RESOLUTION NO. 2021-19**

**WHEREAS**, the City of Hampton (hereinafter "City") is governed by the Mayor and Council; and

**WHEREAS**, the Mayor and Council is committed to committed to protecting and promoting the public health, safety and general welfare of its citizens; and

**WHEREAS**, the City is required by the State to update its Capital Improvement Element ("CIE") with the Atlanta Regional Commission ("ARC") and/or Georgia Department of Community Affairs (hereinafter "DCA"); and

**WHEREAS**, the CIE is a component of a comprehensive plan which sets out projected needs for system improvements during a planning horizon established in the comprehensive plan and includes a schedule of capital improvements that will meet the anticipated need for system improvements, and a description of anticipated funding sources for each required improvement.

**WHEREAS**, the CIE deadline is approaching for the plan's update; and

**WHEREAS**, the City to authorized and it is in the City's best interest for the Community Development Department to draft, submit, and conduct all related assignments with respect to the timely submission of the City's CIE to the DCA and/or ARC; and

**WHEREAS**, the City conducted public hearings to receive and incorporate comments from Hampton citizens on the CIE;

**NOW THEREFORE IT IS HEREBY RESOLVED** that the Mayor of the City of Hampton authorizes the Community Development Department to transmit the City of Hampton's CIE as a portion of the Comprehensive Plan, as revised with citizen comment to the DCA and ARC by the State imposed deadline.

RESOLUTION NO. 2021-20

**WHEREAS**, the Mayor and Council are the governing body of the City of Hampton, Georgia "City");  
and

**WHEREAS**, the Mayor and Council is tasked with protecting and promoting the health, safety, morals and welfare of the citizens of the City of Hampton; and

**WHEREAS**, the November 2, 2021 is a municipal election and there will be a vote on a Henry County "County" referendum; and

**WHEREAS**, at present, City voters have to vote in two separate precincts when there is a City election and a County election in the same year; and

**WHEREAS**, the City has determined that a change of the polling place for the November 2, 2021 will reduce confusion to voters where there is a City and County election in the same year; and

**WHEREAS**, for the November 2, 2021 election and any other elections where there are both City and County elections, the City seeks to change its polling precincts from the Fortson Library to Berea Christian Church, 37 Woolsey Road and Calvary Baptist Church, 109 Oak Street, both of which are in the City of Hampton and consistent with the County precincts; and

**WHEREAS**, the change of precincts for election day voting furthers the City's desire to align its polling precincts with the County; and


**WHEREAS**, the City has properly advertised in the Henry Herald on July 28, 2021 and August 4, 2021 its intent to change its current polling place for the November 2, 2021 election day voting from Fortson Library Berea Christian Church and Calvary Baptist Church; and

**WHEREAS**, this resolution shall not impact early voting which is dictated by the County and will continue at Fortson Library.


**BE IT HEREBY RESOLVED**, by a majority vote of the Mayor and Council of the City of Hampton that for election day voting beginning November 2, 2021, the polling location for the City of Hampton is relocated from the Fortson Library to Berea Christian Church and Calvary Baptist Church. This change in the polling place is effective immediately in time for the November 2021 elections. The Clerk is hereby instructed and authorized to provide notification and post all signage as required by law as result of this change.


