**A RESOLUTION OF THE CITY OF HAMPTON'S MAYOR AND COUNCIL AUTHORIZING THE COUNTY ELECTION SUPERINTENDENT TO CONDUCT EARLY VOTING FOR THE NOVEMBER 2021 ELECTION; TO PROVIDE FOR SEVERABILITY; TO REPEAL ALL CONFLICTING RESOLUTIONS; TO PROVIDE FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City of Hampton (hereinafter "City") is governed by the Mayor and Council; and

**WHEREAS**, there is a City election and County question on the ballot for the November 2, 2021 election; and

**WHEREAS**, the Georgia General Assembly allows for the governing authority to allow for early/advance voting to include on a Saturday and/or Sunday in the November 2021 election pursuant to Title 21, Chapter 2, Section 385 of the Code of Georgia; and

**WHEREAS**, the City contracts with Henry County ("County") for the provision of election services by and through the County Election Superintendent; and

**WHEREAS**, the County Election Superintendent shall have jurisdiction over the advance voting and shall exercise all duties and powers granted per Title 21 and Senate Bill 202; and


**WHEREAS**, the City desires to approve the attached and incorporated dates provided to the City by the County as the early/advance voting dates for the November 2021 election, attached hereto at **Exhibit "A"**; and

**WHEREAS**, these dates are allowed per O.C.G.A. 21-2-385; and

**NOW, THEREFORE** in consideration of the applicable law and benefit to the citizens, the City approves the attached (Exhibit "A") County dates for early/advance voting which also are to be published by the election superintendent.
