- Call to Order
  - The Meeting was called to order by Kenda Woodard, Director Hampton Main Street at 6:35 p.m.
- Motion to Amend the Agenda
  - Motion to amend the agenda was made by Alford Williams and seconded by Marquita Walton. The vote was unanimous.
- Welcome & Introduction of Staff
  - Kenda Woodard, Director Hampton Main Street
    - Began by informing the newly appointed board members of her background as a returning employee to the City of Hampton as of January 2024 and having been a Main Street Manager/Director since 2013 serving as Main Street and Tourism Executive Director for the Griffin Spalding Business and Tourism Association. Ms. Woodard also spent 30 years as the Director of Operations for multiple Public Housing Authorities.
  - Wanda Moore, Director Community Development
    - Shared her background as a Community Planner and a Landscape Architect having worked in the public and private sector. As a planner Ms. Moore's job is to be a primary player in envisioning the City of Hampton's future growth and direction as well as carrying out the goals identified in various COH plans including; the Comprehensive Plan, the King, George, and Daniel Streets Revitalization Strategy



along with other LCI Initiatives. Ms. Moore's department also enforces city zoning ordinances regarding and issues permits/licenses.

- Ms. Shirley Johnson stated that she is an HOA board member in her community and that she is interested in learning about and preserving the history of Hampton.
