**RESOLUTION NO. 2025-64**

**A RESOLUTION AUTHORIZING ACCEPTANCE OF CONVEYANCE  
OF PERPETUAL PERMANENT SEWER EASEMENT AND TEMPORARY  
CONSTRUCTION EASEMENT FROM THLJ INVESTMENTS, LLLP, FOUR  
SITE HOLDINGS, LLLP, AND BEAR CREEK INVESTMENTS, L.P, TO THE  
CITY OF HAMPTON FOR THE INSTALLATION AND PERPETUAL  
MAINTENANCE OF SEWER INFRASTRUCTURE AS DESCRIBED IN  
MINTER DRIVE SEWER AGREEMENT.**

**WHEREAS**, the Mayor and Council are the governing body of the City of Hampton, Georgia (“City”); and

**WHEREAS**, the Mayor and Council are tasked with protecting and promoting the health, safety, morals, and welfare of the citizens of the City of Hampton; and

**WHEREAS**, on September 9, 2025, THLJ INVESTMENTS, LLLP, a Georgia limited liability partnership, FOUR SITE HOLDINGS, LLLP, a Georgia limited liability limited partnership, and BEAR CREEK INVESTMENTS, L.P. a Georgia limited partnership provided the City of Hampton Permanent Sewer Easement Agreement and Temporary Construction Easement conveyances for Minter Drive Sewer Extensions.

**WHEREAS**, said Permanent Utility Easement and Temporary Construction Easement Agreement proposed for dedication to the City of Hampton as described in “Exhibit A, A.1-7, and depicted in “Exhibit B, Page 1-6; and

**WHEREAS**, said area of Permanent Sewer Easement and Temporary Construction Easements are located in Land Lots 78 and 83 of the 3<sup>rd</sup> District, City of Hampton, Henry County, Georgia; and

**WHEREAS**, an off-site sanitary sewer improvement plan has been reviewed by the City of Hampton engineer indicating the proposed easement dedication and design intent adheres to best practice standards for infrastructure design and City of Hampton sewer development regulations and design standards; and

**WHEREAS**, the Engineer of Record is required under Section 3-7 of the Subdivision Regulations to submit an “as-built” drawing of the public improvements including sewer; and

**WHEREAS**, in order to provide orderly development of the sewer improvements, the City deems it in the best interest of the City of Hampton that the Conveyance as Permanent Sewer Easement Agreement be accepted and the same become part of the public infrastructure system of the City of Hampton.

**NOW, THEREFORE BE IT RESOLVED**, by a majority vote of the Mayor and Council of the City of Hampton, that dedication and acceptance of sewer easement within as shown on the Minter Drive Sewer agreement, is hereby approved.
