**WHEREAS**, it is in the City's best interest to authorize the City Manager to contract with SOL Construction, LLC.





Falcon Design Consultants, LLC (FDC) reviewed the information submitted by the low bidder for this project including the references submitted for this project as part of the bid documents. Based upon the information received from those references and the information submitted as part of the bid package, FDC believes that **Sol Construction LLC** has experienced personnel, professional management staff, and financial resources to perform the referenced project.

FDC therefore recommends award of the contract for the City of Hampton's – E. Main St N & Elm St Intersection Improvements project to **Sol Construction LLC**. This recommendation is for the total base bid submitted. If approved, the contract will be awarded in the bid amount of Two Hundred Eighty-Nine Thousand, Six Hundred Seventy-Seven Dollars (\$289,677.00).
