ORDINANCE NO. 2022-574

AN ORDINANCE TO AMEND THE FISCAL YEAR (FY) 2022 BUDGET; TO CREATE A LINE ITEM FOR THE CALDWELL DRIVE PROJECT IN THE CAPITAL FUNDS OUTLAY PROJECTS BUDGET; TO FUND THE CALDWELL DRIVE PROJECT LINE ITEM WITH A TRANSFER OF FUNDS IN FROM THE KYNDAL DRIVE PROJECT IN THE AMOUNT OF \$463,420.00; TO PROVIDE AN ADOPTION AND EFFECTIVE DATE; AND TO PROVIDE FOR OTHER LAWFUL PURPOSES.

THE COUNCIL OF THE CITY OF HAMPTON HEREBY ORDAINS:

SECTION 1. FY2022 Budget Amendment.

WHEREAS, the Mayor and Council are the governing body of the City of Hampton, Georgia; and

WHEREAS, the City of Hampton sets and produces a budget to cover the City's collections and expenses each fiscal year; and

WHEREAS, the City is currently operating in the Fiscal Year ("FY") 2022 budget and seeks to make changes in appropriations in accordance with City Charter Section 6.29; and

WHEREAS, the City has a Capital Funds Outlay Project budget for various public works projects in the City; and

WHEREAS, the Kyndal Drive Project, a culvert replacement, was budgeted at \$650,000.00 but was completed underbudget at \$186,580.00; and

WHEREAS, the City discovered a new stormwater project at Caldwell Drive that needs attention; and

WHEREAS, the City desires to make an amendment to the FY2022 budget to allow for the creation of a new line item for the Caldwell Drive Project and fund said line item with a transfer of \$463,420.00 from the completed and over-funded Kyndal Drive Project; and

WHEREAS, said funding is appropriated from reducing the appropriation to the Capital Project Fund, Kyndal Drive Project line item by \$463,420.00, creating a new line item in the same fund for the Caldwell Drive Project, and transferring the \$463,420.00 to the newly created line item for the Caldwell Drive Project; and

WHEREAS, the City has determined that this budget amendment is necessary and a good use of taxpayer funds; and

BE IT HEREBY ORDAINED, by a majority vote of the Mayor and Council of the City of Hampton, that the FY22 budget be amended to reflect the following:

- Creation of a new line item in Capital Project Fund named Caldwell Drive Project.
- Reduction of \$463,420.00 in Kyndal Drive Project line item transfer.
- Increase the new Caldwell Drive Project line item to \$\$463,420.00.

Section 2. The preamble of this Ordinance shall be considered to be and is hereby incorporated by reference as if fully set out herein.

Section 3. This Ordinance shall be codified in a manner consistent with the laws of the State of Georgia and the City of Hampton.

Section 4. This Ordinance shall take effect immediately upon its adoption. All Ordinances in conflict herewith are expressly repealed. It is the intention of the governing body, and it is hereby ordained that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances, City of Hampton, Georgia, and the sections of this Ordinance may be renumbered, if necessary, to accomplish such intention.

Section 5.

- a. It is hereby declared to be the intention of the Mayor and Council that all sections, paragraphs, sentences, clauses and phrases of this Ordinance are or were, upon their enactment, believed by the Mayor and Council to be fully valid, enforceable and constitutional.
- b. It is hereby declared to be the intention of the Mayor and Council that, to the greatest extent allowed by law, each and every section, paragraph, sentence, clause and phrase of this Ordinance is severable from every other, section, paragraph, sentence, clause or phrase of this Ordinance. It is hereby further declared to be the intention of the Mayor and Council that, to the greatest extent allowed by law, no section, paragraph, sentence, clause or phrase of this Ordinance is mutually dependent upon any other section, paragraph, sentence, clause or phrase of this Ordinance.
- c. In the event that any phrase, clause, sentence, paragraph or Section of this Ordinance shall, for any reason whatsoever, be declared invalid, unconstitutional or otherwise unenforceable by the valid judgment or decree of any court of competent jurisdiction, it is the express intent of the Mayor and Council that such invalidity, unconstitutionality or unenforceability shall, to the greatest extent allowed by law, not render invalid, unconstitutional or otherwise unenforceable any of the remaining phrases, clauses, sentences, paragraphs or Sections of the Ordinance and that, to the greatest extent allowed by law, all remaining phrases, clauses,


sentences, paragraphs and Sections of the Article shall remain valid, constitutional, enforceable, and of full force and effect.

Section 6. All ordinances and parts of ordinances in conflict herewith are hereby expressly repealed.

Section 7. The effective date of this Ordinance shall be the date of adoption unless otherwise specified herein.
