ORDINANCE NO. 2022-586

**AN ORDINANCE TO AMEND THE FISCAL YEAR (FY) 2022
BUDGET; TO ALLOW FOR A BALANCED BUDGET TO CLOSE
OUT THE FISCAL YEAR ENDING (FYE) SEPTEMBER 30, 2022;
TO PROVIDE AN ADOPTION AND EFFECTIVE DATE; AND TO
PROVIDE FOR OTHER LAWFUL PURPOSES.**

THE COUNCIL OF THE CITY OF HAMPTON HEREBY ORDAINS:

SECTION 1. FYE2022 Budget Amendments.

WHEREAS, the Mayor and Council are the governing body of the City of Hampton, Georgia; and

WHEREAS, the City of Hampton sets and produces a budget to cover the City's collections and expenses each fiscal year; and

WHEREAS, the City is currently operating in the Fiscal Year Ending ("FYE") September 30, 2023, budget and seeks to make changes in appropriations in accordance with City Charter Section 6.29; and

WHEREAS, the City originally budgeted a specific amount for various expenditures and/or income and the FYE2022 budget needs to be amended to match said expenditures and/or income; and

WHEREAS, the City has determined that the budget amendments attached hereto at **Exhibit "A"** and incorporated by reference are necessary to close out FYE2022 budget as balanced;

BE IT HEREBY ORDAINED, by a majority vote of the Mayor and Council of the City of Hampton that the FYE2022 budget be amended to reflect the changes in the attached **Exhibit "A"**.

Section 2. The preamble of this Ordinance shall be considered to be and is hereby incorporated by reference as if fully set out herein.

Section 3. This Ordinance shall be codified in a manner consistent with the laws of the State of Georgia and the City of Hampton.

Section 4. This Ordinance shall take effect immediately upon its adoption. All Ordinances in conflict herewith are expressly repealed. It is the intention of the governing body, and it is hereby ordained that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances, City of Hampton, Georgia, and the sections of this Ordinance may be renumbered, if necessary, to accomplish such intention.

Section 5.


- a. It is hereby declared to be the intention of the Mayor and Council that all sections, paragraphs, sentences, clauses and phrases of this Ordinance are or were, upon their enactment, believed by the Mayor and Council to be fully valid, enforceable and constitutional.
- b. It is hereby declared to be the intention of the Mayor and Council that, to the greatest extent allowed by law, each and every section, paragraph, sentence, clause and phrase of this Ordinance is severable from every other, section, paragraph, sentence, clause or phrase of this Ordinance. It is hereby further declared to be the intention of the Mayor and Council that, to the greatest extent allowed by law, no section, paragraph, sentence, clause or phrase of this Ordinance is mutually dependent upon any other section, paragraph, sentence, clause or phrase of this Ordinance.
- c. In the event that any phrase, clause, sentence, paragraph or Section of this Ordinance shall, for any reason whatsoever, be declared invalid, unconstitutional or otherwise unenforceable by the valid judgment or decree of any court of competent jurisdiction, it is the express intent of the Mayor and Council that such invalidity, unconstitutionality or unenforceability shall, to the greatest extent allowed by law, not render invalid, unconstitutional or otherwise unenforceable any of the remaining phrases, clauses, sentences, paragraphs or Sections of the Ordinance and that, to the greatest extent allowed by law, all remaining phrases, clauses, sentences, paragraphs and Sections of the Article shall remain valid, constitutional, enforceable, and of full force and effect.

Section 6. All ordinances and parts of ordinances in conflict herewith are hereby expressly repealed.

Section 7. The effective date of this Ordinance shall be the date of adoption unless otherwise specified herein.



City of Hampton, Georgia

Fiscal Year 2022 Budget Amendment recommendation:

The City's General Fund Operating Budget

Source of Funding: General Administration Department FY22 Budget to be decrease by \$54,000 for Account 100-1500-52-3100- Insurance Liability/Bond, reducing Original Budget amount of \$303,745 to \$249,745.

Departments in FY22 Operating Budget to increase:

Information Technology: \$34,000 for Account 100-1535-54-2500 Computer Upgrades, increasing Original Budget amount of \$0 to \$34,000.

Municipal Court: \$12,000 for Account 100-2650-57-1020 Prosecutor Training Fund, increasing Original Budget amount of \$31,817 to \$43,817.

and \$8,000 for Account 100-2650-57-1030 Peace Officer Annuity & Benefit Fund, increasing Original Budget amount of \$11,817 to \$19,817.
