ORDINANCE NO. **2021-555**

AN ORDINANCE OF THE CITY OF HAMPTON'S MAYOR AND COUNCIL PURSUANT TO CITY CHARTER SECTION 6.11 TO SET A MILLAGE RATE; TO PROVIDE FOR THE APPLICABLE ROLBACK; TO PROVIDE FOR SEVERABILITY; TO PROVIDE FOR AN EFFECTIVE DATE.

WHEREAS, the City of Hampton (hereinafter "City") is governed by the Mayor and Council; and

WHEREAS, the City is a taxing authority; and

WHEREAS, the City is required to set a millage annually pursuant to City Charter § 6.11; and

WHEREAS, the millage rate is the tax rate used to calculate ad valorem taxes; and

WHEREAS, the City is required to rollback its millage rate to offset the City's share of Local Option Sales Tax (hereinafter "LOST") in accordance with O.C.G.A. § 48-8-91 and to offset any increases as a result of the revaluation of the County's digest; and

WHEREAS, the City's current gross millage is 13.428 mills; and

WHEREAS, the City intends to rollback its millage to net 0 mills; and

NOW THEREFORE, the millage for calendar year 2021 for personal and real property is gross 13.428 mills prior to the LOST rollback and 0 mills net after the LOST rollback;

Section 1. **BE IT HEREBY ORDAINED**, by a majority vote of the Mayor and Council of the City of Hampton, the millage rate after all applicable rollbacks is set at net 0 mills for calendar year 2021.

Section 2. The preamble of this Ordinance shall be considered to be and is hereby incorporated by reference as if fully set out herein.

Section 3. This Ordinance shall be codified in a manner consistent with the laws of the State of Georgia and the City of Hampton.

Section 4. This Ordinance shall take effect immediately upon its adoption. All Ordinances in conflict herewith are expressly repealed. It is the intention of the governing body, and it is hereby ordained that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances, City of Hampton, Georgia, and the sections of this Ordinance may be renumbered, if necessary, to accomplish such intention.



In the event that any phrase, clause, sentence, paragraph or Section of this Ordinance shall, for any reason whatsoever, be declared invalid, unconstitutional or otherwise unenforceable by the valid judgment or decree of any court of competent jurisdiction, it is the express intent of the Mayor and Council that such invalidity, unconstitutionality or unenforceability shall, to the greatest extent allowed by law, not render invalid, unconstitutional or otherwise unenforceable any of the remaining phrases, clauses, sentences, paragraphs or Sections of the Ordinance and that, to the greatest extent allowed by law, all remaining phrases, clauses, sentences, paragraphs and Sections of the Article shall remain valid, constitutional, enforceable, and of full force and effect.

Section 6. All ordinances and parts of ordinances in conflict herewith are hereby expressly repealed.

Section 7. The effective date of this Ordinance shall be the date of adoption unless otherwise specified herein.


